3. The user accepts full responsibility, and agrees to indemnify and hold the copyright holder harmless, for any consequences resulting from the use of the SSQ.

4. The user accepts full responsibility, and agrees to indemnify and hold the copyright holder harmless, for the accuracy of any translations of the SSQ into another language and for any errors, omissions, misinterpretations, or consequences thereof.

5a. Academic groups requesting use of SSQ translations are given automatic permission for use with one copy of each questionnaire as requested. Attribution should be given to the Epilepsy Therapy Project for making the SSQ available.

5b. Non-Academic groups interested in using the SSQ translations should contact Joyce Cramer for additional information. No other group may provide copies of the questionnaires for non-academic use.
